Thank you for your application dated 30<sup>th</sup> January 2026, received by us on the same date.

Your request was made in the following terms:

The record(s) "From 2023 to 2026: 1. Documents detailing allegations by any prisoner, including indecent assault, sexual misconduct, or physical impropriety by any lawyer against a prisoner in 2023, 2024, 2025, or 2026. 2. Investigation reports, outcomes, or disciplinary actions stemming from prisoner complaints against any lawyer during 2023, 2024, 2025, or 2026. 3. Grievances filed by inmates naming any lawyer, including those involving indecent assault, sexual misconduct, or physical impropriety from 2023-2026."

We have carefully considered your request for information under the Freedom of Information Act. Unfortunately, this public authority does not hold any relevant record(s) and, to our knowledge, neither does any other public authority. Therefore, we have not transferred your request and will close this file after making a record of our search efforts.

Under section 33 of the FOI Act, you may ask for an Internal Review of this decision. You have 30 calendar days after receiving this notice to request an Internal Review of this decision. Any request for Internal Review must be in writing, including email, and can be sent using the contact details below. While you may include the basis on which you are requesting an Internal Review, this is not required.

If, upon Internal Review, this public authority's decision is still not favourable to you, you have the right under section 42 of the FOI Act to appeal to the Ombudsman within 30 days of:

- the date of notification of the decision taken at Internal Review; or
- the date on which you should have been notified of the decision taken at Internal Review if you receive no notification.
