Dear Mr. Lindsay,

Thank you for your application dated May 13, 2024, received by us on May 13, 2024 by email from the Ministry of Finance which received the request from Cabinet Office. However, the transfer of the request was not transferred in Jade to the Treasury Department until May 17, 2024.

On reviewing the questions outlined in your request I have to advise that the Treasury does not hold information in relation to all of your questions and/or information that directly addresses your questions, which seek information in a specific format. However, the records we do hold that are relevant to your request are already published and available to the public. These include reports from the Auditor General that include the management response from the Ministry of Finance & Economic Development, recorded hearings before the Public Accounts Committee (PAC) where these matters have been discussed, and reports from the PAC to Parliament. The FOI Act provides a general right of access to records that are held by a public authority and does not require the creation of information not already held. Pursuant to section 9(d) of the FOI Act, public authorities are also not required to comply with requests for information that is already in the public domain.

If you are dissatisfied with this decision that has been made pursuant to the FOI Act, you have the right under section 42 of the FOI Act to appeal to the Ombudsman within 30 days of receiving this notice. An internal review of this matter is not possible because the Accountant General was consulted on this request and involved in this initial decision.
